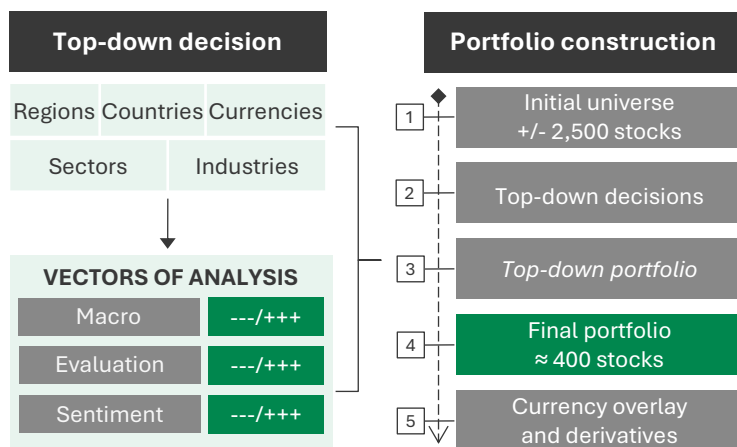

- Shareholder engagement:** In collaboration with the responsible investment team, we encourage companies to improve their consideration of ESG criteria.
- Exclusions:** tobacco and controversial weapons
